(top 3 contestants will be notified by 3/18/22 so they may purchase conference tickets and reserve hotel room if needed)

Who May Enter?

The video contest is open to all CAP cadets, one entry per team of 1 to 3 cadets.

Judging will be based on:

- Thoughtfulness of video topic (25%)
- Proper representation of CAP logos and uniforms (20%)
- Proper representation of CAP safety practices (15%)
- Relevance of video theme to specified topic (20%)
- Meets all requirements outlined in rules and guidelines (10%)
- Visual and audio clarity, ability to easily follow along (10%)

Rules & Guidelines

Create a video keeping one of the following topics in mind:

- Topics
 - CAP recruiting
 - CAP safety Issue
- Video may be serious or have slight humor.
- Videos must be 2-5 minutes in length.
- In the event of a tie the team who has the highest score in the following category order will win the tiebreaker: Proper representation of CAP logos and uniforms, Proper representation of CAP safety practices, Relevance of video theme to specified topic.
- Video may not incorporate any copyrighted characters (i.e., comic and/or television characters), photographs, and magazine or newspaper illustrations.
- Video must be original cadet work with no adult assistance.
- Teams will be made up of no more than three cadets, each cadet may only be on one team and each team may only submit one video.
- Cadets and Seniors may participate in multiple videos as actors and there is no limit to the number of actors in each video.

- Entrants must obtain the consent of each person appearing in the video to be recorded and must have them acknowledge that the video may be publicly posted. In the event a person appearing in the video is a minor, consent must be obtained from that person's parent or legal guardian. Failure to do so will disqualify the entry.
- Video may not discuss the Air Force or display its insignia and emblems.
- **ATTENTION:** Please accurately follow all requirements and restrictions, as failure to do so will subject the entry to disqualification. All winning entries become the property of Civil Air Patrol which reserves the right to modify any video for reproduction purposes.
- Only one entry per team will be allowed. NO TEAM MAY SUBMIT MULTIPLE ENTRIES.

How to Enter:

1. Create your video.
2. Once you've finished and are ready to enter, attach your video to an email and submit it to Valerie.Schroder@txwg.cap.gov along with a completed entry, consent, and release forms by the contest end date and time.
3. Entries submitted without completed entry, consent, and release forms will be disqualified.
4. Once your entry has been reviewed, you will receive a confirmation email (keep this for your records).
5. All winners will be notified via email and results will be posted to the Texas Wing website.
